## ANTITERRORISM AWARENESS MONTH

August is Antiterrorism Awareness Month, and this is an important opportunity for everyone to increase their understanding and knowledge regarding extremism, terrorism, insider threats, cybersecurity threats, vulnerabilities, and other risks. The threat to U.S. National Security is becoming increasingly more dynamic and complex. Adversaries are looking for new ways to target or destroy their enemies, such as the U.S., for political, ideological, or religious purposes.

#### WHAT IS ANTITERRORISM?

Antiterrorism is the defense measure taken to detect, deter, and defend against potential or actual terrorist plans or acts.

#### **RECOGNIZING TERRORISM**

- International terrorism: Violent, criminal acts committed by individuals and/or groups who are inspired by, or associated with, designated foreign terrorist organizations or nations (state-sponsored).
- Domestic terrorism: Violent, criminal acts committed by individuals and/or groups to further ideological goals stemming from domestic influences, such as those of a political, religious, social, racial, or environmental nature.





#### **HOW TO PROTECT YOURSELF**

It is important to protect yourself both online and inperson, and to report any suspicious activity you may encounter. Here are a few ways to stay protected:

- Remain aware of your surroundings.
- Refrain from oversharing personal information.
- Say something if you see something. The insular nature of today's violent extremists makes them difficult for law enforcement to identify and disrupt before an attack. Many times, a person's family or friends may be the first to notice a concerning change in behavior that may indicate a person is mobilizingto violence.



### **RECOGNIZING EXTREMISM**

A religious, social, or political belief system that exist substantially outside of belief systems more broadly accepted in society. Extreme ideologies often seek radical changes in the nature of government, religion or society. Extremism can also be used to refer to the radical wings of broader movements, such as the anti-abortion movement or the environmental movement. Some of the factors that can lead to extremism are triggering events, terrorist belief systems, identity processes, connections with other violent extremists on social networks or offline, violent extremist belief systems and narratives, group dynamics, and grievances.
